

## Delegation of Authority -- Supplemental



The undersigned, signers of the Institution named below (the "PFI"), hereby delegate the authority previously granted to the undersigned by the PFI's Board of Directors to conduct transactions with the Federal Home Loan Bank (the "Bank") as certified in that certain ***Resolution for Mortgage Partnership Finance<sup>®</sup> Program*** dated \_\_\_\_\_ ("Resolution") to each officer, employee or authorized person of the PFI ("Designated Person") named in this Delegation of Authority, each acting individually, solely for the purpose(s) designated for each such person beside his or her name. The Bank shall be entitled to rely on any action taken within the scope of this delegation by any such Designated Person. Only the Designated Persons designated as Security Administrators shall have the authority to further delegate their powers as set forth in section (3)(b) of the Resolution; all other Designated Persons shall not have the authority to further delegate the powers designated herein.

This Delegation of Authority supplements all prior Delegations of Authority by the PFI with respect to the Mortgage Partnership Finance Program on file with the Bank and shall be in full force and effect and binding upon the PFI until written notice of its rescission is delivered to the Bank and the Bank has been afforded a reasonable opportunity to act on such notice.
